AN EMERGENCY ORDINANCE
To amend Section 11 of Ordinance No. 194-2021, passed March 29, 2021, as amended, relating to salaries for various classifications.

FOR PASSAGE
January 6, 2025

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Section 11 of Ordinance No. 194-2021, passed March 29, 2021, as amended, to read as follows:

Section 11. ~~International Union of Operating Engineers, Local 10~~ Teamsters Local 507 (Utility Supervisors). That salaries and compensation in the following classifications shall be fixed by the appointing authority in accordance with the schedule appearing after each classification:

Section 2. That the existing Section 11 of Ordinance No. 194-2021, passed March 29, 2021, as amended, is repealed.

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
