

Division of Water/Cleveland Public Power/Water Pollution Control/Department of Public Works

Request for Legislation

An ordinance to authorize the Department of Public Utilities (DPU) and the Department of Public Works (DPW) to enter into one or more requirement contracts for the rental of various heavy-duty equipment. Legislation will lead to one or more contracts for a term of two years.

Background/Purpose:

Department of Public Utilities - DPU (Division of Water-CWD, Cleveland Public Power-CPP and Water Pollution Control-WPC) own, operate and maintain major utilities, and needs the ability to rent various heavy-duty equipment to assist in maintaining prompt service to their customers.

Department of Public Works - DPW maintains approximately 200 facilities and has need of construction and aerial lift equipment to perform timely repairs.

Scope of Work/Commodities/Services:

The vendor shall supply various, heavy-duty, rental equipment that meets the requirements of the contract specifications. The types of equipment include, but is not limited to, compressors, demolition equipment, drilling equipment, blowers, mixers, trowel machines, scissor lifts, telescopic booms, wood chippers, loaders, backhoes, trackhoes, excavators, bulldozers, pressure washers, skidloaders and trenchers. Equipment will be available for delivery or pick-up. Rental periods shall be by the day, week, or by the month. The two departments may need this equipment, 24 hours per day, 7 days per week.

Anticipated Costs and funding source:

The funding source will be each divisions' operating budget. The projected estimates for each of the two years are as follows:
