Subject: Intent to gift improvements to the City of Cleveland

This letter is to confirm that Western Reserve Land Conservancy (“WRLC”) intends to gift improvements to the City of Cleveland (the “City”) on approximately 0.5 acres of City of Cleveland-owned land known as permanent parcel number (PPN) 106-23-040 associated with the Thurgood Marshall Recreation Center. WRLC anticipates that these improvements will include new sidewalks, new tree plantings, and new site amenities (such as picnic tables) (the “Improvements”) totaling an approximate value of \$50,000. The Improvements will be made in conjunction with WRLC’s Hough Green Space project on the adjacent WRLC-owned PPN 106-22-179.
