Whereas, there remains an unappropriated balance in the various funds, the sum of Ten Million Four Hundred Ten Thousand (\$10,410,000) which is available for additional appropriation; and Whereas, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That there is hereby appropriated the additional revenue as set forth in the Amended Official Certificate of Estimated Resources previously unappropriated as follows:
