AN EMERGENCY ORDINANCE

Consenting and approving the issuance of a permit for the Cleveland Cocoa Run 5K, February 7, 2026, managed by Hermes Sports & Events and repealing Ordinance No. 1313-2025, passed October 20, 2025.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the holding of the Cleveland Cocoa Run, February 7, 2026, managed by Hermes Sports & Events; START: outside Annunciation Greek Orthodox Church (2187 West 14th Street) and head north on trail near Side Yard Park - turn Right on Abbey Avenue - turn left on West 11th Street - turn right on University Road and get on the Towpath Trail - stay on the Towpath Trail past West 4th Street and Houston Avenue - turnaround on Towpath Trail - Stay on the Towpath Trail past Houston Avenue and West 4th Street - continue straight on University Road - turn left on to West 11th Street - turn right on Abbey Avenue - turn left and return on Trail near Side Yard Park – FINISH: outside Annunciation Greek Orthodox Church; provided that the applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

Section 2. That Ordinance No. 1313-2025, passed on October 20, 2025, is hereby repealed.

Section 2. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
