AN EMERGENCY ORDINANCE

Authorizing the Director of Finance to enter into an amendment to Contract No. CT 0114 PS 2023-0002 with the Child Care Resource Center of Cuyahoga County, dba Starting Point, for additional funds for eighteen eligible households to continue to provide funding for early childhood education for the Department of Finance.

WHEREAS, that under the authority of Ordinance Nos. 905-2022, and 906-2022, passed September 19, 2022, and Ordinance No. 545-2024, passed May 20, 2024, the Director of Finance entered into Contract No. CT 0114 PS 2023-0002 (the "Contract") with the Child Care Resource Center of Cuyahoga County, dba Starting Point, to provide funding for early childhood education, amongst other things (the "Program"), to eligible low income households; and

WHEREAS, the families receiving funds under the Program require additional funding to continue in the Program through the end of 2025; and

WHEREAS, it is necessary to amend the Contract to include additional funds for eligible households; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operations of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Finance is authorized to enter into an amendment the Contract, for additional funds for eighteen (18) eligible households to continue to provide funding for early childhood education, amongst other things, in an amount not to exceed \$120,000.00. All other terms and conditions of the contract shall remain the same.

Section 2. That the additional cost of the Contract authorized shall be paid from Fund No. 01-0114-6380 and from any other funds approved by the Director of Finance.

Section 3. That the amendment to the Contract shall be prepared by the Director of Law.

Section 4. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
