Ord. No. 1256-2023

By Council Members Bishop and Griffin (by departmental request)

An emergency ordinance to amend Sections 185.01 and 185.08 of the Codified Ordinances of Cleveland, Ohio, as amended by various ordinances; to repeal Section 185.02, Advertisement for Bids; and to supplement the codified ordinances by enacting new Sections 185.011, 185.012, and 185.02 relating to construction contracting. Remarks by Director of Public Works Department: See Legislation.

Ord. No. 1269-2023

By Council Members Hairston, Bishop and Griffin (by departmental request)

An emergency ordinance authorizing the Director of Capital Projects to enter into one or more agreements with the City of East Cleveland regarding the public improvement of resurfacing Woodward Avenue between Hayden Avenue to Coit Road, to among other items, allow East Cleveland to make the public improvement of resurfacing the portions on Woodward Avenue which are located in the City of Cleveland; and to cause payment to the City of East Cleveland for the City's portion of the improvement.
