#### Ord. No. 1256-2023

By Council Members Bishop and Griffin (by departmental request)

An emergency ordinance to amend Sections 185.01 and 185.08 of the Codified Ordinances of Cleveland, Ohio, as amended by various ordinances; to repeal Section 185.02, Advertisement for Bids; and to supplement the codified ordinances by enacting new Sections 185.011, 185.012, and 185.02 relating to construction contracting. #### Ord. No. 1269-2023
