**Section 1.** That objection to the renewal of a C1 and C2 Liquor Permit to 3258 East 140<sup>th</sup> Street, Inc., DBA Abell Foods, 3258 East 140<sup>th</sup> Street, Cleveland, Ohio 44120, Permit Number 8871287, be and the same is hereby withdrawn and Resolution No. 973-17, containing such objection, be and the same is hereby repealed and that this Council consents to the immediate permit thereof.

**Section 2.** That this resolution is hereby declared to be an emergency measure and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
