AN EMERGENCY ORDINANCE

To amend Section 135.071 of the Codified Ordinances of Cleveland, Ohio, 1976, as amended by Ordinance No. 1188-12, passed September 10, 2012, relating to maximum age for original appointment to the Divisions of Police and Fire.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Section 135.071 of the Codified Ordinances of Cleveland, Ohio, 1976, as amended by Ordinance No. 1188-12, passed September 10, 2012, are amended to read as follows:

Section 135.071 Maximum Age for Original Appointment to the Divisions of Police and Fire

- (a) No person is eligible to receive an original appointment to the Division of Police as a Police Trainee on or after the person's fortieth fifty-fifth birthday.
- (b) No person is eligible to receive an original appointment to the academy for the Division of Fire on or after the person's fortieth birthday.

Section 2. That existing Section 135.071 of the Codified Ordinances of Cleveland, Ohio, 1976, as amended by Ordinance No. 1188-12, passed September 10, 2012, are repealed.

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
