WHEREAS, this ordinance constitutes an emergency measure providing for the

usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Section 22 of Ordinance No. 194-2021, passed March 29, 2021,

as amended by Ordinance No. 701-2023, passed June 5, 2023, and Ordinance No. 776-

2023, passed July 12, 2023, is amended to read as follows:

<u>Section 22.</u> <u>Cleveland Association of Rescue Employees (CARE), Local 1975.</u> That salaries and compensation in the following classifications shall be fixed by the appointing authority in accordance with the schedule appearing after each classification:
