### AN EMERGENCY ORDINANCE

Authorizing the Director of Finance to consent to assignment of Contract No. MA 1505-RCD 2015-93 from Webtech Wireless Inc. dba InterFleet, Inc. to BSM Analytics Inc. dba Mobi Corp.

WHEREAS, under Ordinance No. 832-14, passed March 2, 2015, as amended by Ordinance No. 710-15, passed July 22, 2015, this Council authorized the Director of Finance to enter into Contract No. MA 1505 RCD 2015-93 with Webtech Wireless Inc. dba InterFleet Inc. ("Webtech") relating to hosting, maintaining, and replacing, as needed, components of the automated vehicle locator system; and

WHEREAS, under Ordinance No. 869-19, passed August 21, 2019, Council approved exercising the option to extend the contract for an additional year; and

WHEREAS, BSM Analytics Inc. dba Mobi Corp. ("Mobi") has purchased Webtech and Webtech wishes to assign all of their rights, obligations, and benefits under Contract No. MA 1505 RCD 2015-93 to Mobi; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Finance is authorized to consent to the name change of the contractor and consents to assignment of Contract No. MA 1505 RCD 2015-93 from Webtech to Mobi.

Section 2. That the Director of Finance is authorized to execute all documents and do all things necessary and appropriate to effect the consent to assignment. A copy of the assignment shall be filed in the Office of the Commissioner of Accounts.

<u>Section 3.</u> That this assignment shall be prepared by the Director of Law.

Section 4. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
