Dear Mayor Bibb and Mses. Britt and Howard:

The Cleveland Clinic Foundation ("CCF") submits this Notice of Operations for calendar year 2023 pursuant to Chapter 686 of the Codified Ordinances of the City of Cleveland on behalf of all CCF health system and emergency facilities operating in the City of Cleveland. CCF has limited its response to those facilities and operations located within the City of Cleveland as CCF interprets the scope of Chapter 686 as applicable only to hospitals and emergency facilities located within the City of Cleveland.

Attached are the most recent letters that we have received from the Ohio Department of Health confirming each hospital's registration and bed classifications. The letters are in accordance with annual reporting requirements pursuant to Section 3701.07 of the Ohio Revised Code and Rule 3701-59-05 of the Ohio Administrative Code (referred to as "ODH Reports" in the attached table).

With respect to a list of "staff members," CCF has included in this Notice a good faith estimate of the total number of employees in 2023 per facility, since the number fluctuates with normal business operations. Therefore, this listing excludes any part time, "leased employees" and "independent contractors," as those terms include a wide range of temporary workers, vendors, suppliers, consultants, etc., all of whom CCF believes in good faith to be outside the scope of this Notice.
