

Division of Water

Request for Legislation

An ordinance authorizing the Division of Water to enter into one or more requirement contracts for the services and materials to maintain and repair water pumps, electric motors, controls, transformers, circuit breakers, switchgear and appurtenances, for a period of two years.

Background/Purpose:

The Division of Water has four drinking water plants and ten secondary pump stations, each of which have water pumps of various sizes, motors of various voltages, and associated appurtenances.

The pumps, motors, controls, transformers, circuit breakers, switchgear, and appurtenances used during the production and supply of potable water are subject to environmental, mechanical, electrical, and chemical degradation. If maintenance and refurbishments are not performed, the capacities of the water system becomes reduced and degraded.

Scope of Work/Commodities/Services:

These contracts will maintain and repair CWD's pumps, motors, controls, transformers, circuit breakers, switchgear, and appurtenances, including but not limited to inspection, supplies, repairing, and testing.

Justification/Urgency:

The maintenance of this equipment requires technical expertise, supplies, and parts that are unavailable within the Division of Water. The operation and integrity of the pumps and motors are critical for the production and supply of potable water for the health and welfare of the population of the City of Cleveland and 79 neighboring communities.

Anticipated Costs and funding source:

These contracts are estimated to cost \$1,000,000.00 per the duration of the contract period(s). Operating or Capital Funds will be used as appropriate to the procurement being made.

Year 1 = \$500,000.00

Year 2 = \$500,000.00

Schedule or Term of Contract:

Legislation is to lead to new Requirement Contracts for the term of up to two years.
