AN EMERGENCY ORDINANCE

To provide for the transfer and amendment of ~~Four Hundred Sixty Five Thousand Dollars (\$465,000)~~ Four Hundred Thousand Dollars (\$400,000) within the General Fund.

WHEREAS, in accordance with Section 41 of the Charter, the Mayor has recommended in writing the within transfer; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That to provide for the transfer and amendment, described in File No. ~~659-2026-A~~, of ~~Four Hundred Sixty Five Thousand Dollars (\$465,000)~~ 659-2026-B, of ~~Four Hundred Sixty Five Thousand Dollars (\$465,000)~~ Four Hundred Thousand Dollars (\$400,000) within the General Fund, as follows:
