PRECINCTS WITH NEW VOTING LOCATION FOR THE 2020 GENERAL ELECTION**

This letter is to notify you that effective immediately, your voting location has permanently moved. Your new voting location beginning with the November 3, 2020 Presidential General Election will be:

The Board of Elections has taken a multitude of factors into consideration when finalizing the decision on relocating your voting location. Due to the social distancing requirements needed for COVID-19, many of the sites we traditionally utilized as polling locations, such as residential senior citizen and healthcare facilities are no longer available to us to use in order to help mitigate any potential risks to populations identified as vulnerable.

You may notice a different look in your voting location from previous elections. These changes are being implemented to ensure that you have a positive and safe voting experience. There will be social distancing 6-foot decals on the floors; staff will wear face coverings and gloves when servicing voters; and a Sanitation Official will sanitize all surfaces within the voting location before and after each voter's use.

Our staff continues to work hard to ensure this transition will be as seamless as possible and hope you will find this voting location suitable to you and your fellow voters. Be on the lookout for our Voter Information Guide the first week of October 2020 as a reminder of your voting location change. We ask that you review the information you receive, as you must cast your ballot at this voting location on Election Day.

- Please note that social distancing may extend the length of the lines on Election Day.

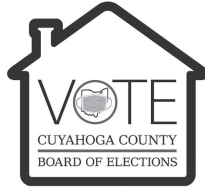

  - 2 We will mail your ballot to you with a return envelope.
  - 3 Vote your ballot and return it before Election Day.
- ! Use the **Track My Ballot** tool on our website to track your ballot application and ballot throughout the process!

**Note:** Voters will receive ballot applications from the Ohio Secretary of State. You do not need to submit more than one ballot application.

To receive your ballot, you must first show your ID to the election officials and then sign the pollbook.

##### What ID should I bring?

- ✓ An unexpired Ohio Driver's License, State ID Card, or Interim Documentation with your former address is **an acceptable form of ID** when your current address is in the poll book. Driver's licenses or State Identification cards set to expire on or after March 9, 2020, are automatically extended and remain valid through the November 3, 2020 General Election.
- ✗ Your passport or any notice from a Board of Elections, **including this postcard**, is **NOT** an acceptable form of ID for voting purposes.
