SUBJECT: Neighborhood Safety Fund Quarter 2 Report

Round Three of funding for the Neighborhood Safety Fund was conducted through an invitation-only process, designed to identify organizations best equipped to reduce gun violence by delivering coordinated services to individuals at the highest risk.

This round prioritized core elements of a comprehensive community violence intervention (CVI) strategy, including:

- **Violence interruption and street outreach**
- **Victim services and hospital-based interventions**
- **Mental health and grief support services**

Building on lessons from previous funding rounds and informed by the expertise of violence prevention and intervention practitioners, we invited seven organizations to submit proposals. Each organization responded to a formal Request for Proposals (RFP) and presented their approach in person to the Neighborhood Safety Fund Advisory Committee on June 6.

Collectively, the invited organizations requested **\$2,088,771** in funding. After a rigorous review process, the committee selected **five organizations** to receive a total of **\$829,000** in support.

While we are proud to invest in several high-impact organizations through this round, the process also underscored a broader challenge: the limited number of organizations with the infrastructure and capacity to perform community violence intervention and interruption practices and the necessary sector coordination to sustain long-term violence prevention efforts.

Per the requirements outlined in our signed fund agreement, please find information identifying the entities receiving funding as well as those denied funding during this third round of funding from the Neighborhood Safety Fund.

The Cleveland Foundation does not have permission from our Round 1 (2023) and Round 2 (2024) grantees to share reports with external entities nor is it our policy to do so. Starting with Round 3 (2025) Neighborhood Safety Fund grantees, we have informed everyone who applies that their reports may be shared with the City of Cleveland and Cleveland City Council in the

future. However, we are happy to provide this summary of the Round 1 Funding reports we have received to date:

- Round One funding supported approximately 8,000 people with mental health, mentorship, safe passages, K-8 prevention / intervention and high school prevention and intervention needs
- 90% of Organizations worked with males ages 11 – 17
- 10% worked with adults aged 18 and older on mental health and employment services
- Funds provided were for general operating support, helping organizations build their capacity to serve
- Dollars allowed funded organizations to solidify their infrastructure, eliminate barriers to access and establish space for program and administrative operations
- We learned that funded organizations needed assistance with fund development, communication, networking and marketing/outreach. To address this need, the Cleveland Foundation paid for and retained the services of Janus Small and Associates to deliver a cohort-based curriculum focusing on building the capacity of grantees and develop these skills.
