

Ordinance No. 75-2026

AN EMERGENCY ORDINANCE

Consenting and approving the issuance of a permit for the Cleveland St. Patrick's Day Run on March 14, 2026, managed by Hermes Sports & Events.

FOR PASSAGE
February 2, 2026

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the holding of the Cleveland St. Patrick's Day Run on March 14, 2026. **START:** West 6th St. By Velvet Dog (1280 West 6th Street) - head toward Superior Avenue - turn right on Superior Avenue - turn right on West 25th Street - turn right on Washington Avenue - turn left of Elm Avenue - turn left on River Road - turn left on Center Street - turn right on Winslow Avenue - turn right on Washington Avenue - turn left on West 25th Street - turn left on Detroit Road –turn left on West 6th Street **FINISH:** West 6th Street by Velvet Dog (1280 West 6th Street); provided that the applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

Section 2. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
