Request for Legislation

Cleveland Water wishes to amend Ordinance 654-15, exercising the first one-year option to renew requirement contracts with Kurtz Bros., Inc. (MA RC2016-52) and Emerald Environmental Service, Inc. (MA RC2016-51). These contracts are for the hauling of dewatered and semi-dewatered residuals from the Crown Water Treatment Plant.

Background / Purpose:

Residuals are by-products of the water purification process and must be removed continuously, as large quantities are produced daily.

Scope of Work / Commodities / Services:

These contracts are needed to remove dewatered and semi-dewatered residuals from our Crown Water Works Plant, located in Westlake, Ohio. These residuals are by-products of water purification and must be removed continuously, as large quantities are produced daily. The Division's other treatment plants send their residuals via force mains to the Northeast Ohio Regional Sewer District. The city of Westlake is not part of that system. Westlake / Rocky River has a small waste water plant which does not have the capacity to treat Crown's residuals.

Approximately 350 truckloads of dewatered residuals are hauled away from Crown each year. Quantities can fluctuate monthly, depending on the amount of residuals produced. Water conditions and the amount of water treated determine how often the residuals will need to be picked up. The frequency will increase during high production periods or when Lake Erie has high levels of suspended solids.

Justification / Urgency:

The removal of dewatered and semi-dewatered residuals is needed to insure that the Crown water treatment facility will continue to function. The operation and integrity of this facility is critical for the production and supply of potable water, for the health and welfare of Cleveland Water's customers.

Anticipated Costs and Funding Source:

General Operating Funding and other sources of funding approved by the Finance Director will be used for these contracts.

Schedule or Term of Contract:

The request is to exercise the additional first one-year option.
