### Letter from the Chairman

Dear Downtown Cleveland Improvement Corporation Members:

I ask your support for reauthorizing the Downtown Cleveland Improvement District for another term. The District's governing body, Downtown Cleveland Improvement Corporation (DCIC), serves as a steward of Downtown Cleveland's public realm and provides services rooted in best practices utilized across the county. Through our dedicated staff, DCIC has achieved some extraordinary results in the most challenging of times.

The urban cores of cities throughout the United States are under distinct stress and strain. This is the result of a confluence of many factors, including:

- The pandemic and resulting impact of reduced work patterns on downtown office buildings, and the overall reduction of pedestrian activity in urban areas.
- The dramatic increase in online shopping and resulting reduction of brick-and-mortar retail.
- The increasing challenges on local police departments to hire and retain qualified police officers.
- The increase in the unhoused population, encampments, and proliferation of drug use.
- A general disrespect of civil norms, and the increase in emboldened criminal activity, including incidents of gun violence and automobile break-ins.

Many U.S. cities have been torn by these national trends. While the City of Cleveland has not been spared, by many accounts our city has suffered much less than others. DCIC has played an important role in this battle by providing a visible presence and boots on the ground, serving as the eyes and ears for enforcement authorities.

There are over 1,000 special improvement districts (referred to as SIDs or BIDs) throughout the United States. In the City of Cleveland alone, there are seven such districts, and our district is one of them. Everywhere, property owners have made the decision to create and sustain SIDs to protect their investments and enhance and foster law and order, cleanliness, and civility. No SID can eliminate the many challenges facing our cities, but they can and do provide an incremental measure of order for our fellow citizens and also promote a favorable investment environment - one block at a time, one day at a time. And that is what DCIC is doing, as reflected in the attached summary of key performance indicators and related data. Please take a moment to review and absorb the magnitude of the information presented.

Downtown Cleveland, Inc. brings together property owners, businesses, residents, and civic partners to nurture and champion our downtown. **Please know that Downtown Cleveland raises 95 cents for every dollar property owners contribute through DCIC.** These resources fund most downtown economic development, advocacy, and placemaking initiatives essential to building a clean, safe, and investment-ready core.

With this packet and the attached petition, we seek your formal support to keep DCIC in effect for the renewal period. Please take a moment to review the materials, and we encourage you to get in touch and become engaged in this ongoing effort to protect and nurture our beloved city.

We will be scheduling informational sessions over the next couple of months to outline our work and our goals, and to discuss new technologies and strategies. We welcome your input in this process. Details of these sessions will follow.

## **Downtown Cleveland, Inc. is a leader in property tax reform.**

Downtown Cleveland, Inc. President & CEO, Michael Deemer, and Board Chair, Karen Fanger, led a successful initiative to limit third party contests of property tax valuations. Through this advocacy, Ohio Sub. House Bill 126 was passed to relieve property owners of spending money on long, cyclical litigation brought by third parties and end a broken system of repeated complaints, counterclaims, and appeals based on property owner feedback.





## Programs + Services

### Clean + Safe

The Clean & Safe Program is funded 100 percent by property owners. Over 75 percent of Downtown Cleveland Improvement District assessments go to clean and safe services.

### Court Watch

Our staff tracks court proceedings of repeat offenders and attends key hearings to advocate on behalf of the downtown community and emphasize the impact chronic criminal behavior has on the neighborhood and local businesses. Court Watch also allows our team to advocate for individuals who should be on the mental health docket and directed to the services and support they need.

### Unhoused Outreach and Advocacy

Our Ambassador team includes a full-time outreach specialist who builds relationships with unsheltered individuals, conducts routine wellness checks, and connects them with social services, housing, medical care, and mental health treatment.

Our Advocacy Committee champions improved shelter conditions and enforceable policies to address issues impacting the neighborhood, such as Mayor Bibb's A Home for Every Neighbor program. Through this program, Downtown Cleveland serves as a fiscal agent for a \$2.7 million grant to connect unsheltered individuals with supportive housing.

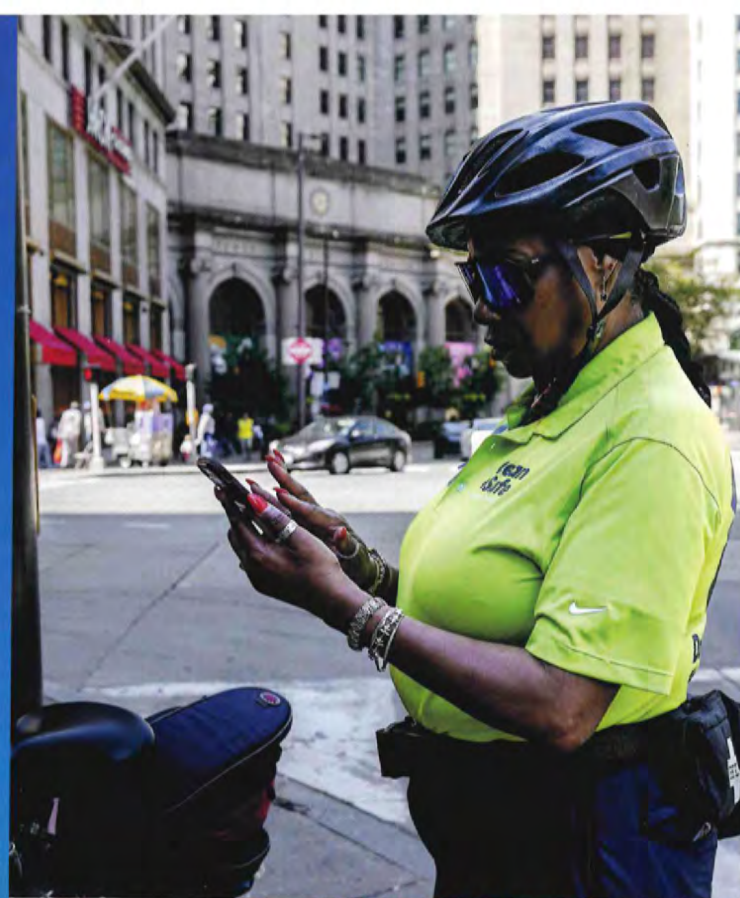
