AN EMERGENCY ORDINANCE

Consenting and approving the issuance of a permit for the TJ Carrie Heart Warrior Run/Walk, June 27, 2026, managed by Hermes Sports & Events.

FOR PASSAGE

April 20, 2026

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the TJ Carrie Heart Warrior Run/Walk event, on June 27, 2026, managed by Hermes Sports & Events; START: on the path ear left field of Jose Ramirez Field – turn right on trail – turn right onto Towpath Trail – stay on the Towpath Trail past West 4th Street and Houston Avenue – Turnaround on Towpath Trail – stay on the Towpath Trail past West 4th Street and Houston Avenue – turn left to head towards right field of Jose Ramirez Field – FINISH: on the path near the right field pole of Jose Ramirez Field; provided that the applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

Section 2. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
