AN EMERGENCY ORDINANCE

Authorizing the Director of Capital Projects to apply to the District One Public Works Integrating Committee for state funding for the rehabilitation of a portion of Wade Park Avenue; to apply for and accept gifts and grants from various entities for the improvement; and authorizing the Commissioner of Purchases and Supplies to acquire, accept, and record for right-of-way purposes real property and easements necessary to make the improvement.

WHEREAS, under Article VIII, Section 2k of the Ohio Constitution, the State of Ohio is authorized to issue bonds and other obligations of the State for the purpose of financing public infrastructure capital improvements of political subdivisions as designated by law; and

WHEREAS, under Section 164.03 of the Revised Code, the District One Public
Works Integrating Committee has been created to evaluate applications for state
financing of capital improvement projects of local subdivisions in Cuyahoga County; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Capital Projects is authorized to apply to the District One Public Works Integrating Committee for state funding for the rehabilitation of a portion of Wade Park Avenue from East 66th Street to East 118th Street (the "Improvement").

Section 2. That the Director of Capital Projects is authorized to apply to the District One Public Works Integrating Committee for state funding to obtain credit enhancements and loan assistance in support of the city's bonds issued for bridge and road improvements.

Section 3. That the Director of Capital Projects is authorized to accept one or more grants from the Ohio Public Works Commission, acting by and through its Director, to finance the Improvement; that the Director of Capital Projects is authorized to file all papers and execute all documents necessary to receive the funds under the grant; and that the funds are appropriated for the purposes described in this ordinance.

<u>Section 4.</u> That the Director of Capital Projects is authorized to apply for and accept gifts or grants or other funds from public or private entities, that the Director is

authorized to file all papers and execute all documents necessary to receive the funds;

and that the funds are appropriated for the purposes of this ordinance.

That notwithstanding any provision of the Codified Ordinances of Section 5.

Cleveland, Ohio, 1976, to the contrary, the Commissioner of Purchases and Supplies is

authorized to acquire, accept, and record for right-of-way purposes any real property

and easements necessary to make the Improvement, including but not limited to gift, fee

simple acquisitions, temporary and permanent easements, and work agreements. The

consideration to be paid for the property and easements shall not exceed fair market

value to be determined by the Board of Control.

That the Director of Capital Projects is authorized to execute, on Section 6.

behalf of the City, all documents necessary to acquire, accept, and record the property

and easements and to employ and pay all fees for title companies, surveys, escrows,

appraisers, and all other costs necessary for the acquisition of the property and

easements.

That the Director of Capital Projects is authorized to enter into any Section 7.

agreements needed to implement the Improvements, including but not limited to,

multi-party agreements between the City and other governmental entities regarding the

Improvement. (RQS 0103, RLA 2025-103)

That this ordinance is declared to be an emergency measure and, Section 8. provided it receives the affirmative vote of two-thirds of all the members elected to

Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period

allowed by law.
