## **AN EMERGENCY ORDINANCE**

Amending the Title and Section 1 of Ordinance No. 414-2020, passed May 27, 2020, as it pertains authorizing the Director of the Department of Aging to enter into an agreement with the Lexington Bell Community Center for the Emergency Food Card Program through the use of Ward 7 Casino Revenue Funds.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

**Section 1.** That the Title and Section 1 of Ordinance No. 414-2020, passed May 27, 2020, are hereby amended to read as follows:

An Emergency Ordinance authorizing the Director of the Department of Aging to enter into an agreement with Famicos Foundation the Lexington Bell

Community Center for the Emergency Food Card Program through the use of Ward 7 Casino Revenue Funds.

Section 1. That the Director of the Department of Aging is authorized to enter into an agreement effective May 1, 2020 with Famicos Foundation Lexington Bell Community Center for the Emergency Food Card Program for the public purpose of providing food cards for senior citizens, needy families and disabled persons in the city of Cleveland who have been severely impacted by the coronavirus pandemic through the use of Ward 7 Casino Revenue Funds.

Section 2. That the Title and Section 1 of Ordinance No. 414-2020 passed May 27, 2020 are hereby repealed

**Section 3.** That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
