The purpose of this letter is to apprise your office that The Community Builders, Inc. plans to be the managing member of a residential rental development located in or within a one-half mile radius of your political jurisdiction, and will submit an application to utilize the multifamily funding programs of the Ohio Housing Finance Agency (OHFA) for the development of this property.

Alta Villa Flats (proposed development) located in Cleveland, Ohio includes the new construction of 50 units of affordable housing for families of low to moderate income.
