## AN EMERGENCY ORDINANCE

Consenting and approving the issuance of a permit for the Hofbräuhaus Run on August 6, 2023, managed by Hermes Sports & Events.

**FOR PASSAGE**  
**May 1, 2023**

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the holding of the Hofbräuhaus Run on August 6, 2023; **5K Course:** START on Chester Avenue at Hofbräuhaus at 1550 Chester Avenue; continue on Chester Avenue; turn right onto East 55th Street; turn right onto Euclid Avenue; turn right onto East 18th Street; turn left onto Chester Avenue to Finish at Hofbräuhaus; **Half Course:** START on Chester Avenue heading west; left on East 13<sup>th</sup> Street; left on Euclid Avenue; left on East 21<sup>st</sup> Street; right on Chester Avenue; left on East 101<sup>st</sup> Street; right on Mt. Sinai Drive; left on Martin Luther King Jr. Drive; turn around and follow Martin Luther King Jr. Drive; right on East 105<sup>th</sup> Street; right on Mt. Sinai Drive; left on east 101<sup>st</sup> Street; right on Chester Avenue; left on East 90<sup>th</sup> Street; right on Euclid Avenue; right on East 18<sup>th</sup> Street; left on Chester Avenue to Finish at Hofbräuhaus; **10K Course:** START on Chester Ave and head east; turn right on East 90th Street; turn right on Euclid Avenue; turn right on East 18th Street; turn left on Chester Avenue to Finish at Hofbräuhaus; provided that the applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

Section 2. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
