

# Ordinance No. 609-2026

## AN EMERGENCY ORDINANCE

Authorizing the Director of City Planning to exercise the second option to renew Contract No. PS 2024-0030 with Stantec Consulting Services, Inc. to provide professional services for on-call planning services.

WHEREAS, under the authority of Ordinance No. 1200-2023, passed November 27, 2023, the Director of City Planning entered into Contract No. PS 2024-0030 with Stantec Consulting Services, Inc. to provide professional services for on-call planning services.; and

WHEREAS, Ordinance No. 1200-2023 requires additional legislation to exercise the first, second, and third options to renew; and

WHEREAS, the first option to renew was authorized under Ordinance No. 1167-2024, passed January 13, 2025; as amended by Ordinance No. 800-2025, passed August 13, 2025; and

WHEREAS, Ordinance No. 1200-2023 requires further legislation before exercising the second option to renew on this contract; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of City Planning is authorized to exercise the second option to renew Contract No. PS 2024-0030 with Stantec Consulting Services, Inc. to provide professional services for on-call planning services. This ordinance constitutes the additional legislative authority required by Ordinance No. 1200-2023 to exercise this option and shall not exceed \$200,000 for the second option year.

Section 2. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
