The purpose of this letter is to apprise your office that Old Brooklyn LLC is to be the owner of a residential rental development located in or within a one-half mile radius of your political jurisdiction, and will submit an application to utilize the multifamily funding programs of the Ohio Housing Finance Agency (OHFA) for the development of this property.

Old Brooklyn will be a newly constructed affordable housing development consisting of 45 units. The 45-unit affordable development will be affordable to and occupied by residents earning 30% - 60% Area Median Income. Residents of the property will have access to onsite amenities such as a fitness center and a community space.

The proposed development will be financed with 9% Housing Tax Credit proceeds, HOME funds, and the Housing Development Loan program.
