BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLEVELAND:

**Section 1.** That objection to the transfer of ownership of a C1, C2 and D6 Liquor Permit to Falguni Krupa, LLC, DBA Convenient Food Mart Store #365, 3584 West 105<sup>th</sup> Street, Cleveland, Ohio 44111, Permit Number 2630329, be and the same is hereby withdrawn and Resolution No. 1288-17, containing such objection, be and the same is hereby repealed and that this Council consents to the immediate permit thereof.

**Section 2.** That this resolution is hereby declared to be an emergency measure and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
