

# Ordinance No. 714-2026

## AN EMERGENCY ORDINANCE

Authorizing the Director of Parks and Recreation to enter into a property adoption agreement with MMH Park LLC, or its designee, to improve and maintain Meet Me Here Park, a City park, located on Huron Road across from Rocket Arena; and to allow and accept various donations from MMH Park LLC of improvements to the park, as a gift to the City.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That, notwithstanding and as an exception to the provisions of Chapters 181 and 183 and Section 131.23 of the Codified Ordinances of Cleveland, Ohio, 1976, the Director of Parks and Recreation is authorized to enter into a property adoption agreement with MMH Park LLC, or its designee (“MMH”), to improve and maintain Meet Me Here Park, a City park, located on Huron Road across from Rocket Arena, formally known as PPN 101-28-036 and as depicted on the map placed in File No. 714-2026-A.

Section 2. That this property adoption shall not be construed as a conveyance of any right, title, or interest in public property, but is the grant of a privilege revocable at the will of this Council.

Section 3. That the property adoption agreement shall be at no cost to either party and the original term of this agreement shall be for up to an initial five (5) year term with four five-year options to renew, exercisable by mutual agreement of the parties, unless terminated by either party.

Section 4. That the agreements shall be prepared by the Director of Law and shall contain additional terms and conditions that the Director deems necessary to protect and benefit the public interest.

Section 5. That the Director of Parks and Recreation is authorized to allow and accept various donations from MMH of improvements to the park, including but not limited to, team logos, installation of a professional-size basketball court with themed graphics honoring the 2016 Cavaliers Championship season, seating, commemorative banners, decorative planters, and other site improvements, a trail, tree plantings, lighting and waste receptacles to all be installed at Meet Me Here Park as a

gift to the City. The various donations from MMH of improvements to the Park are depicted in the illustrative concept included in the file referenced above. The total estimated value for the installations and site improvements is \$1,190,000.00.

Section 6. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
