

THERE IS NO LEGAL OBJECTION TO THIS LEGISLATION IF AMENDED AS FOLLOWS:

1. In Section 1, at amended Section 453.01(b), line 3, strike "eight dollars (\$8.00) per hour" and insert "three dollars (\$3.00) per hour and up to eight dollars (\$8.00) per hour during special events in Special Event Zones described below"; in line 4, strike "for up to eight hours, and" and insert "for up to eight hours, and"; and in line 5, strike "after eight hours" and insert "after eight hours".

2. In Section 1, at amended Section 453.01(b)(1), line 1, strike "Thursday" and insert "Saturday"; in line 2 and 3, strike "8:00 p.m.; Fridays from 7:00 a.m. to 10:00 p.m.; Saturdays from 4:00 p.m. to 10:00 p.m.;" and insert "10:00 p.m.;".

3. In Section 1, at amended Section 453.01(b)(2), line 2, strike "6:00" and insert "8:00"; and insert new division 453.01(b)(3) to read as follows:

"(3) In Special Event Zones described below: Monday through Sunday.

1. Gateway Special Event Zone includes Prospect Avenue between West 3rd Street and West 2nd Street; Prospect Avenue between East 9th Street and East 14th Street; West 2nd Street between Prospect Avenue and West Huron Road; West Huron Road between West 6th Street and Ontario Street; Huron Road East between Prospect Avenue and Euclid Avenue; and Carnegie Avenue between East 9th Street and East 14th Street.

2. Lakefront Special Event Zone includes East 12th Street between South Marginal Road and Saint Clair Avenue Northeast; East 17th Street between Lakeside Avenue East and Saint Clair Avenue Northeast; Lakeside Avenue East between East 9th Street and East 17th Street; Saint Clair Avenue Northeast between East 9th Street and East 17th Street; Hamilton Avenue between East 13th Street and East 17th Street.

4. In Section 1, at amended Section 453.01(c), beginning in line 8, strike "Thursday between the hours of ~~10:00~~ 8:00 until 7:00 a.m. the following morning, Fridays between the hours of 10:00 p.m. until 7:00 a.m. the following morning, Saturdays between the hours of 10:00 p.m. until 4:00 p.m. the following day," and insert "Saturday between the hours of 10:00 p.m. until 7:00 a.m. the following morning,"; and in line 12, strike "6:00" and insert "8:00".

5. In Section 1, at amended Section 403.04(a), beginning in line 3, strike "Thursday between ~~10:00~~ 8:00 p.m. and 7:00 a.m., Fridays between the hours of 10:00 p.m. and 7:00 a.m., and Saturdays between the hours of 10:00 p.m. until 4:00 p.m." and insert "Saturday between the hours of 10:00 p.m. and 7:00 a.m.".

6. In Section 1, at amended Section 403.06(b)(10), line 4, strike "May 15," and insert "June 1,".
