adopted June 2, 2025, regarding the approximate boundaries of the Gordon Square Arts District – Cleveland Improvement District.

### FOR PASSAGE July 9, 2025

WHEREAS, under the authority of Resolution No. 669-2025, adopted June 2,

2025, this Council approved the creation of the Gordon Square Arts District - Cleveland

Improvement District (the "District") pursuant to Chapter 1710 of the Ohio Revised

Code; and

WHEREAS, the City desires to amend the approximate boundaries of the District

stated in Resolution No. 669-2025, adopted June 2, 2025, to exactly match the

description provided in File No. 669-2025-B contained in the Resolution; and

WHEREAS, this resolution constitutes an emergency measure providing for the

usual daily operation of a municipal department; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Section 2 of Resolution No. 669-2025, adopted June 2, 2025,

is amended to read as follows:

<u>Section 2.</u> That, under Chapter 1710 of the Revised Code, the District is hereby created with approximate boundaries as follows:

Consisting of Detroit Avenue, between West 58th <u>Street</u> and West 73rd <u>Street</u> <del>Streets,</del> as well as a portion of the west sides of both West 65th <u>Street</u> <del>and West 67 Streets,</del> <u>to include PPN 00209024 and West 67<sup>th</sup> Street to include PPN 00209023,</u> as shown in <u>the</u> map placed in <del>the</del> <del>above mentioned, file, to include active store fronts along those sides of</del> <del>West 65<sup>th</sup> and 67<sup>th</sup> Streets.</del> <u>File No. 669-2025-B contained in Resolution</u> <u>No. 669-2025, adopted June 2, 2025</u>.

Section 2. That the existing Section 2 of Resolution No. 669-2025, adopted

June 2, 2025, is repealed.

<u>Section 3.</u> That this resolution is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
