

# Ordinance No.1295-2025

## **AN EMERGENCY ORDINANCE**

Authorizing the Director of Capital Projects to enter into an amendment to the memorandum of understanding with the Greater Cleveland Regional Transit Authority to provide additional services for improvements and extend the contract.

---

WHEREA, the Director of Capital Projects entered into a Memorandum of Understanding with the Greater Cleveland Reginal Transit Authority ("GCRTA") for track and platform bridge rehabilitation over W. 117<sup>th</sup> Street, that was authorized under Ordinance No. 568-2022, passed July 13, 2022 (the "Agreement"); and

WHEREAS, due the change in conditions, additional quantities of concrete wall patching is needed and the Director of Capital Projects is authorized to extend the length of the term through December 31, 2025; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Capital Projects is authorized to enter into an amendment to the Agreement with the GCRTA to add services for the improvements, in an amount not to exceed \$29,600.00 for a total of \$170,000.00 and to extend the term of the contract through on December 31, 2025. All other terms and conditions of this contract shall remain the same.

Section 2. That the additional cost of the contract or contracts authorized shall not exceed \$29,600.00 and shall be paid from Fund Nos. 20 SF 568, 20 SF 574, 20 SF 579, 20 SF 586, 20 SF 592, 20 SF 702, 20 SF 712, ~~and other funds~~ as approved by the Director of Finance. (RQS 0103, RL 2022-73)

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
