AN EMERGENCY ORDINANCE

Authorizing the Director of the Department of Parks and Recreation to enter into agreement with Fairfax Renaissance Development Corporation for the Cleveland Inner City Boxing Club Project providing activities free to the public increasing the opportunity to learn boxing technique and physical fitness training through the use of Ward 6 Casino Revenue Funds.

WHEREAS, providing venue and activities free to the public encouraging boxing technique, sports and physical fitness training for adults and school-age youth for residents of the City of Cleveland is a valid public purpose for municipal expenditures providing for the health, wellness, and general welfare of the public; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of the Department of Parks and Recreation is hereby authorized to enter into agreement with Fairfax Renaissance Development Corporation for the Cleveland Inner City Boxing Project for the public purpose of providing activities free to the public increasing the opportunity to learn boxing techniques, physical fitness training and physical health activities through the use of Ward 6 Casino Revenue Funds.

Section 2. That the cost of said contract shall be in an amount not to exceed \$15,000.00 and shall be paid from Fund No. 10 SF 188 using the fund and project number from the following Ward:

Ward Amount Project Number

Ward 6 \$15,000.00 G25757

Section 3. Project shall begin as of November 1, 2025.

<u>Section 4.</u> That the Director of Law shall prepare and approve said contract and that the contract shall contain such terms and provisions as he deems necessary to protect the City's interest.

Section 5. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
