### Ord. No. 1198-2024

By Council Members Howse-Jones, Slife and Maurer

An emergency ordinance to supplement the Codified Ordinances of Cleveland, Ohio, 1976, by enacting new Chapter 147 relating to creation of the Department of Community Crisis Response.

### Ord. No. 25-2026

By Council Members Griffin (by departmental request)

An emergency ordinance authorizing the Director of Finance, on behalf of the Cleveland Municipal Clerk of Courts, to apply for and accept a grant from State Justice Institute to conduct the Continuity of Operations Plan; and authorizing the Director to enter into one or more contracts with the National Center for State Courts to establish and execute the Plan.

Estimated Cost: \$7,500

### Ord. No. 26-2026

An emergency ordinance authorizing the Directors of Public Safety or Law to apply for and accept grants from Cuyahoga County Public Safety and Justice Services for the FY 2025 STOP Violence Against Women Act program for a sexual assault advocate and for the Law Enforcement and Prosecution components of the Cleveland Domestic Violence Program; and authorizing one or more contracts with the Cleveland Rape Crisis Center, and other entities to implement the grants.
