## AN EMERGENCY ORDINANCE

Authorizing the Director of Public Works to exercise the first option to renew Contract No. RC 2022-25 with Rumpke of Ohio Inc. for the transfer, disposal and processing of recyclable materials.

WHEREAS, under the authority of Ordinance No. 195-2020, passed March 2, 2020, the Director of Public Works entered into Contract No. RC 2022-25 with Rumpke of Ohio Inc. for the transfer, disposal and processing of recyclable materials; and

WHEREAS, Ordinance No. 195-2020 requires further legislation before exercising the first option to renew on this contract; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Public Works is authorized to exercise the first option to renew Contract No. RC 2022-25 with Rumpke of Ohio Inc. to provide for the transfer, disposal and processing of recyclable materials. This ordinance constitutes the additional legislative authority required by Ordinance No. 195-2020 to exercise this option.

Section 2. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
