<u>FOR PASSAGE</u> June 2, 2025

AN EMERGENCY ORDINANCE

Authorizing and directing the Director of Parks and Recreation to enter into a concession agreement with Jardin 4 Life, Inc. for use of the concession area at Roberto Clemente Park to operate a concession stand to provide food and refreshments to the public during park activities.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

<u>Section 1.</u> That the Director of Parks and Recreation is authorized and directed to enter into a concession agreement ("Agreement") with Jardin 4 Life, Inc. ("Concessionaire") for use of the concession area at Roberto Clemente Park ("Park") in order to operate a concession stand to provide food and refreshments to the public during activities conducted at the Park. The Agreement shall begin as of June 1, 2025 and expire one year thereafter, with 2 one-year options to renew at the request of the Council. The Agreement shall be prepared by the Director of Law and contain such other terms and conditions as that Director deems necessary to protect and benefit the public interest. Concessionaire shall obtain all required permits and licenses necessary to operate the concession under the Agreement.

<u>Section 2.</u> That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
