### **About CIRI**



With an impressive record of more than 460 unique annual site visits, and over 5,500 services provided to address issues, CIRI is dedicated to ensuring that Cleveland's manufacturing sector continues to grow and thrive.








# 2023 CIRI Successes

Three of the many success stories gathered from serving Cleveland Manufacturers





Dealing with car thefts and burglaries, a company sought CIRI's help. CIRI organized a meeting with PPG, First District Police, and a Councilman, resulting in new parking lot lights and a connection to the Real Time Crime Center. CIRI also connected PPG to First Energy for electrical upgrades.



#### ARCHITECTURAL FIBERGLASS INC.

MANUFACTURER AND DESIGNER OF CUSTOM BUILDING ORNAMENTATION (50 FTE, WARD 6)

A family business transformed two vacant parcels into functional space and bought their largest competitor in 2022, increasing their workforce from 35 to 50 FTEs. With CIRI's help, they purchased a new building on E. 82nd to accommodate growth, thanks to a CIRI introduction.



#### **PREMIUM METALS**

**CLEVELAND-BASED STEEL SERVICE CENTER (25 FTE, WARD 15)** 

Facing closure, a business sought CIRI's help. CIRI secured a \$100,000 Jobs Ohio Revitalization Grant, enabling PMI to open a new facility in Ward 5 in 2023. They increased full-time employees from 21 to 25 and plan a \$12 million expansion to double their workforce over the next five years.

We have been operating since 1990 and I've known the CIRI program for many years. We are also investing in and expanding our steel service business. In February 2023, I reached out to my CIRI representatives, Millie Caraballo and Berkys Sosa, for assistance. Cleveland Tofu uses a very unique and custom process to make world class tofu. We are a small woman owned operation in the City of Cleveland. In 2021, our CIRI Rep called us offering her organizations' support to our business.

At the time, we were growing and looking to expand capacity. She has spent the last 2 years working side-by-side with our organization. She has connected us to technical resources and securing capital through Team NEO. We were awarded a \$50,000 Inclusion Grant that allows us to invest in equipment and facility upgrades to continue growing our business.

Melissa Gura, Owner, Cleveland Tofu

Monroe Tool is a 3rd generation family led high tech manufacturing business with over 75 years of history in Cleveland.

For almost a year Manufacturing Works' CIRI program has been assisting us with our expansion plan. They have offered us assistance in a variety of ways. When we purchased the property for our expansion we met with some obstacles-first with the power company and then with Building and Housing. CIRI brought all potential incentives to the table to discuss how they could assist in our project so we could leverage public dollars.

Millie is working with multiple City of Cleveland departments to make sure we get the attention we need. She has also connected us to Manufacturing Works workforce team which is helping to guide us in upskilling our current employees, training our new employees and hopefully connecting us to educational institutions to hopefully get future workforce.

Millie and Manufacturing Works are our go to for anything we need assistance with because we know if they can't help us they will find us someone who can. We are grateful to have them as champions for the manufacturing community.
