## AN EMERGENCY ORDINANCE

Consenting and approving the issuance of a permit for the Cleveland Housing Network Believe in Home 5K and 1 Mile Walk on August 12, 2023, managed by Hermes Sports & Events.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the holding of the Cleveland Housing Network Believe in Home 5K and 1 Mile Walk on August 12, 2023; START-Rocky River Drive immediately north of Lorain Avenue; continue northbound on Rocky River Drive; turn left onto Amber Drive westbound and around cul-de-sac to continue eastbound on Amber Drive; turn right onto Rocky River Drive; turn left on Claire Avenue and continue onto Marquis Avenue; turn left onto Rocky River Drive; turn left onto West Park Road; turn right onto West 159<sup>th</sup> Street; turn right onto Lucille Avenue; turn left onto West 165<sup>th</sup> Street; turn right onto Dartmouth Avenue; turn left onto West 169<sup>th</sup> Street; turn left onto Ferndale Avenue; turn right onto West 165<sup>th</sup> Street; turn right onto Lorain Avenue; turn left onto West 168<sup>th</sup> Street and continue onto Albers Avenue; provided that the applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

Section 2. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
