

Ordinance No. 243-2021**AN EMERGENCY ORDINANCE**

To amend Section 50 of Ordinance No. 194-2021, passed March 29, 2021, relating to compensation for various classifications.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Section 50 of Ordinance No. 194-2021, passed March 29, 2021, is amended to read as follows:

Section 50. Municipal Court Employees. That salaries and compensation in the following classifications shall be fixed by the appointing authority in accordance with the schedule appearing after each classification:

Section 2. That existing Section 50 of Ordinance No. 194-2021, passed March 29, 2021, is repealed.

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
