

# Ordinance No. 846-2020

## AN EMERGENCY ORDINANCE

Authorizing the Director of Port Control to enter into an amendment to Contract No. PS 2017-17 with Peregrine Advisors, LLC to extend the term of the contract up to one year and to provide additional financial consulting services.

WHEREAS, under Ordinance No. 503-16, passed May 23, 2016, this Council authorized the Director of Port Control to enter into Contract No. PS 2017-17 with Peregrine Advisors, LLC to provide financial consulting services; and

WHEREAS, additional services are needed under that contract; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Port Control is authorized to enter into an amendment to Contract No. PS 2017-17 with Peregrine Advisors, LLC to extend the term of the contract up to one year and to provide additional financial consulting services.

Section 2. That the cost of the contract amendment shall not exceed \$350,000 and shall be paid from Fund Nos. 60 SF 001, 60 SF 104, 60 SF 106, 60 SF 114, 60 SF 125, 60 SF 126, 60 SF 141, from the fund or funds to which are credited grant proceeds received for this purpose, and passenger facility charges that include this purpose. Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
