Withdrawing objection to the transfer of location of a D1 D2, D3, D3A and D6 Liquor Permit at 3704 Superior Avenue and repealing Resolution No. 540-2025, objecting to said transfer.

WHEREAS this Council objected to the transfer of location of a D1, D2, D3, D3A and D6 Liquor Permit to Thirty Nine Eleven, LLC, DBA: Thirty Nine Eleven 2nd Floor, 3704 Superior Avenue, Cleveland, Ohio 44114, Permit No. 88693390005 by Resolution No. 540-2025 adopted by the Council on April 21, 2025; and

WHEREAS, this Council wishes to withdraw its objection to the above transfer and consents to said transfer; and

WHEREAS, this resolution constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That objection to the transfer of location of a D1, D2, D3, D3A, and D6 Liquor Permit to Thirty Nine Eleven, LLC, DBA: Thirty Nine Eleven 2nd Floor, 3704 Superior Avenue, Cleveland, Ohio 44114, Permit No. 88693390005, be and the same is hereby withdrawn and Resolution No. 540-2025, containing such objection, be and the same is hereby repealed and that this Council consents to the immediate transfer thereof.

Section 2. That this resolution is hereby declared to be an emergency measure and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
