City of Cleveland, Ohio Code of Ordinaces §161.03 Landmarks Commission, Composition and Terms.

Members to be appointed by the Mayor shall be chosen from nominations made by the Western Reserve Historical Society, the Cleveland Chapter of the American Institute of Architects and the Early Settlers Association. At least one member shall be an owner of commercial or industrial real property; at least one member shall be a registered architect; at least one member shall be a historian qualified in the field of historic preservation; at least one member shall be a licensed real estate broker: at least one member shall be an attorney; and all members shall have, to the highest extent practicable, known interest in landmarks preservation.

Greetings, my name is Chris Loeser. I am an architect and Principal at DLR Group and would like to be considered for nomination to the Cleveland Landmarks Commission. Born and raised in the Cleveland area, I have lived in the Ohio City neighborhood for the past 15 years, and as a homeowner for the past five. In 2021, I was appointed to the Ohio City Design Review Committee where I have had the rewarding opportunity to review and make recommendations for dozens of projects that impact my neighborhood, many of which would later be reviewed by the Cleveland Landmarks Commission.

After graduating from the College of Architecture and Environmental Design at Kent State University in 2007, I joined the design firm Westlake Reed Leskosky (now DLR Group). Over the past 16 years, I have had the opportunity to be involved in a number of projects locally, nationally and internationally, with a primary focus on cultural and performing arts. Much of my work has involved the restoration and renovation of significant historic buildings and historic theatres. It has been my absolute pleasure to work with many of Cleveland's key cultural institutions, in particular, Playhouse Square and Musical Arts Association (The Cleveland Orchestra). I currently serve on the Board of the League of Historic American Theatres and was a juror for the Cleveland Restoration Society and AIA *Celebration of Preservation Awards* in 2017 and 2019. I believe I can bring to the Commission an understanding and empathy for the process of historic preservation, including budgets, an understanding of tax credits and Secretary of the Interior's standards. I understand the complexity and intricacies of the design and construction of such projects at a wide variety of scales, from a few thousand dollars to hundreds of millions. Also, in addition to my time spent on the Ohio City Design Review Committee, I have worked directly with the City of Cleveland and other local municipalities on permitting and design review for a number of projects, and I understand the processes.


