#### AN EMERGENCY ORDINANCE

To make additional appropriations of Thirty Four Million Eight Hundred Thousand (\$34,800,000) to the General Fund, One Million Three Hundred Seventy Five Thousand (\$1,375,000) to the Special Revenue Fund and Ninety Four Thousand (\$94,000) to the Internal Service Fund.

WHEREAS, it is necessary to appropriate balances in various funds, the sum of Thirty Six Million Two Hundred Sixty Nine Thousand (\$36,269,000) which is available for additional appropriation; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

<u>Section 1</u>. That there is hereby appropriated the additional revenue as set forth in the Amended Official Certificate of Estimated Resources previously unappropriated as follows:
