

**Executive Summary**  
**Solid and Infectious Waste and Construction and Demolition Debris Program**

**Ord. No. 1113-2021**

**Background/Purpose:**

- ◆ This legislation authorizes the Director of Public Health to apply for an accept a grant from the Cuyahoga County Solid Waste District (CCSWD) in the approximate amount of \$70,000 for each and every year of the grant, and any other funds that may become available during the grant term and to to enter into a new multi-year contract with the CCSWD for the the City of Cleveland Department of Public Health (CDPH) to conduct the Solid and Infectious Waste and Construction and Demolition Debris Program similar to the current contract.
- ◆ As CDPH has been placed on the Ohio Environmental Protection Agency’s approved list of health districts authorized to administer and enforce the solid and infectious waste and construction and demolition debris laws and rules in accordance with Sections 3734.09 and 3714.09 of the Ohio Revised Code, CDPH will agree in the multi-year contract with CCSWD to use the funds to perform those duties in Cleveland, Ohio.
- ◆ Under the multi-year contract, beginning on January 1, 2022 and ending December 31, 2024, CDPH will review and process applications for permits, conduct inspections, respond to complaints, and maintain associated records and documents regarding the following facilities: (1) Solid Waste Transfer Stations; (2) Scrap tire transporters and storage facilities; Construction and demolition debris landfills/recycling facilities; (3) Compost facilities; (4) Captive landfills; (5) Closed landfills and landfills undergoing closure.
- ◆ In addition CDPH will agree to respond to nuisance complaints and opens dumping complaints, investigate and initiate enforcement action when appropriate in coordination with the Cleveland-Cuyahoga County Environmental Crimes Task Force.
- ◆ The services include assuring quality of data as required by Federal Law and State guidelines.

**This ordinance will continue to authorize the Program to:**

- ◆ Help ensure the proper disposal of solid and infectious waste, construction and demolition debris and scrap tires within the City of Cleveland.
- ◆ Help ensure, through routine inspections and other enforcement activities that solid and infectious waste and construction and demolition debris facilities are operating within the City of Cleveland’s Codified Ordinances and the laws and regulations of the State of Ohio.
