Request for Legislation

Amend Ordinance No. 763-2021 authorizing the Department of Public Utilities to enter into one or more contracts with Windstream Holdings II, LLC for telecommunication service lines for primary and backup communications for SCADA control, security cameras and telephones at multiple locations as follows:

Background/Purpose:

To provide service connectivity to locations outside of Cuyahoga County which are beyond the AT&T service area. The service includes primary and backup communications for SCADA control, security cameras and telephones at multiple locations.

Scope of Work/Commodities/Services:

To enter into a contract with Windstream Holdings II, LLC to pay monthly invoices for our current services and any additional services as needed.

Justification/Urgency:

Windstream Holdings II, LLC provides connectivity to locations that are outside of the AT&T service area. This connectivity is critical to the security and safety to our Water system. This services our outlying water towers, pump stations, and facilities. DPU wishes to continue these services.
