<u>Section 1</u>. That objection to the New C2 Dolgen Midwest, LLC, DBA Dollar General Store, #21810, 10390 St. Clair Avenue, Cleveland, Ohio 44108, Permit No. 22348152755, be and the same is hereby withdrawn and Resolution No. 254-2021, containing such objection, be and the same is hereby repealed and that this Council consents to the immediate permit thereof.

<u>Section 2</u>. That this resolution is hereby declared to be an emergency measure and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
