

Legal Description for Little Italy Neighborhood Boundaries

Beginning at the southeastern corner of PPN 120-31-009 and heading east to the center of line of E. 123rd Street; thence southeasterly along the center line of E. 123rd Street to its intersection with a projection of the northeastern property line of PPN 120-32-001; thence southeasterly along the eastern property line of PPN 120-32-001, PPN 120-32-002, PPN 120-32-004; and PPN 120-32-005 to the northeastern corner PPN 120-32-086; thence southeasterly and southerly along eastern property lines of PPN 120-32-086, PPN 120-32-087, and PPN 120-32-066 to the southeastern corner of PPN 120-32-066; thence northeasterly to its intersection with a projection of the northeast property line of PPN 120-32-064; thence southeasterly along the eastern property lines of PPN 120-32-064; PPN 120-32-063, PPN 120-32-062; PPN 120-32-061, PPN 120-32-043 to the northern property line of PPN 120-32-042; thence easterly along said property line to the northeastern corner of PPN 120-32-042; thence southeasterly along eastern property line of PPN 120-32-042 and PPN 120-32-041 to the southeastern corner of PPN 120-32-041; thence southwesterly along rear property lines of PPN 120-32-041, PPN 120-32-040; PPN 120-32-039; PPN 120-32-038; PPN 120-32-037; PPN 120-32-084; PPN 120-32-043, and PPN 120-32-033 to the intersection of the centerline of Mayfield Road; thence easterly along the centerline of Mayfield Road to its intersection with a projection of the northeasterly property line of PPN 121-32-104; thence southerly along eastern property line of PPN 121-04-104, PPN 121-04-105, PPN 121-04-106, and PPN 121-04-107 to the northeast corner of PPN 121-04-108; thence south along the eastern property line of PPN 121-04-108 to the southern property line of PPN 121-04-108; then southwesterly along the southern property lines of PPN 121-04-008, PPN 121-04-024, PPN 121-04-007, PPN 121-04-028, PPN 121-04-109, PPN 121-04-030; PPN 121-04-031, PPN 121-04-032, PPN 121-04-033, PPN 121-04-034, PPN 121-04-035, PPN 121-04-036, PPN 121-04-037, PPN 121-04-038, PPN 121-04-110, PPN 121-04-113; PPN 121-04-041; PPN 121-04-042; PPN 121-04-043, PPN 121-04-044, PPN 121-04-045, PPN 121-04-046, PPN 121-04-047, PPN 121-04-048 to the eastern property line of PPN 121-05-099; thence southerly along the eastern property line of PPN 121-05-099 to the southeastern corner of PPN 121-05-099; thence southerly along the eastern property line of PPN 121-05-099 to the intersection of the centerline of Edgehill Road; thence southwesterly along the center of line of Edgehill Road to its intersection with the eastern corporate boundary of UCI; thence northwesterly and northeasterly along the eastern corporate boundary of UCI to the southeastern corner of PPN 120-31-009, place of beginning.


