## Ordinance No.: 385-2022

**Purpose of the Request:** The purpose of this request is to authorize the purchase by one or more contracts for professional services, data storage, data analytics, equipment, and software licenses, of various materials, supplies, licenses, and services necessary to update and improve computers, software, peripheral ancillary devices, telecommunications, network infrastructure, Public Safety Systems and Security, Health Systems, Citywide applications, and hosted software services.

This request is to obtain authorization for various technology projects, services and upgrades to existing systems including but not limited to, Website upgrade, Route Optimization, Learning Management Solution, Payroll Processing and Onboarding Software, fiber optic installation, replacing obsolete desktop personal computers, Social Services Software, Data Center Network and Server Upgrades and enhancements migrating physical servers to power efficient, sustainable Blade Chassis and Virtual Servers, upgrade of SharePoint system, Software as a Service, Record Management System, WorkOrder Management, AVL System Upgrade, Camera System, Accela System Upgrade, Voice over Internet Protocol (VoIP) telephone system, WIFI installation in City-owned and City-leased facilities; and installation of Pen based devices, Business Intelligence system, all the foregoing including all associated hardware and appurtenances.

This request for authorization includes the purchase, lease, or license of: computer and network hardware, replacement parts with labor if necessary, software, software licenses, software upgrades, appurtenances, supplies, related furniture, Building Equipment and Restoration, training materials, insurance;

This request for authorization includes the employment by contract of professional services for: project

management, business analysis, network installation and support services, software implementation and configuration, end user and technical staff training and registration, relocation, system design, data report conversion, installation, implementation, development and implementation, testing, technical tuning, administration, maintenance services, upgrades, backup systems and services, system disaster alleviation and remediation, technical support, network administration, implementation, programming, maintenance, and other support for operation and enhancement of systems, integration, data exchange, implementation, migration, installation, design, interfacing, repair, upgrades and enhancements and other related professional services.

Pursuant to Section 108 (b) of the Charter, the purchases authorized by this ordinance may be made through cooperative agreements using state procedures. The Director of Finance may sign all documents with the State of Ohio or any of its political subdivision that are necessary to effectuate such cooperative efforts and may enter into contract with the vendors selected through that cooperative process.
