Ordinance No. 493-2022

AN EMERGENCY ORDINANCE

Authorizing the Director of Finance to enter into amendments to Contract No. PS 2020-105 with Cleveland State University and PS 2020-147 with Case Western Reserve University to continue to provide professional development for the Social Support Services Unit and Neighborhood Resource and Recreation Center Managers and Leadership, for one additional year.

WHEREAS, under Ordinance No. 387-2019, passed April 15, 2019, and various Board of Control resolutions, the Director of Finance entered into Contract No. PS 2020-105 with Cleveland State University ("CSU") and Contract No. PS 2020-147 with Case Western Reserve University ("Case") to provide professional development for the Social Support Services Unit and Neighborhood Resource and Recreation Center Managers and Leadership for a period of one year, with one option to renew for additional one-year period; and

WHEREAS, under Ordinance No. 811-2020, passed November 18, 2020, this Council authorized amendments to agreements entered into under the authority of Ordinance No. 387-2019, to include additional contract provisions, a revision of the scope of services and fees, consultants, and an additional one-year period on the contracts due to the the inability of CSU and Case to provide some or all of the services due to the COVID-19 declared emergencies; and

WHEREAS, an additional one year term is necessary for CSU and Case to provide their intended services; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Finance is authorized to enter into amendments to Contract No. PS 2020-105 with CSU and Contract No. PS 2020-147 with Case to extend the term of their existing contracts for one additional year, in order to provide professional services necessary to continue to provide professional development for the Social Support Services Unit and Neighborhood Resource and Recreation Center Managers and Leadership.

<u>Section 2.</u> That the amendments shall be prepared by the Director of Law.

<u>Section 3.</u> That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
