

# Ordinance No. 568-2022

**By Council Members Mooney, Bishop and Griffin (by departmental request)**

## AN EMERGENCY ORDINANCE

Authorizing the Director of Capital Projects to enter into one or more agreements with the Greater Cleveland Regional Transit Authority to improve roadway curb walls and pedestrian rails under the track and platform bridges over West 117<sup>th</sup> Street; and authorizing payment for the City's cost of the improvement.

WHEREAS, the Greater Cleveland Regional Transit Authority ("GCRTA") is rehabilitating its track and bridge over West 117<sup>th</sup> Street at the border between the cities of Cleveland and Lakewood;

WHEREAS, City roadway elements under such track and bridge are need of improvement;

WHEREAS, the City desires to cooperate with GCRTA in making these improvements; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Capital Projects is authorized to enter into one or more agreements with GCRTA giving consent and providing for the design and making of the improvement of City roadway curb walls and pedestrian rails under the track and platform bridges over West 117<sup>th</sup> Street, and the repair and reinstallation of artwork on such walls, Project ID No. 62A (the "Improvement"). The agreement shall provide that the City shall pay GCRTA for the cost of designing and making the Improvement for the portion that is located within the City of Cleveland.

Section 2. That this Council authorizes payment in the cost not to exceed the amount of \$140,400 to GCRTA for the Improvement.

Section 3. That the cost of the payment to GCRTA shall be paid from Fund Nos. 20 SF 568, 20 SF 574, 20 SF 579, 20 SF 586, 20 SF 592, 20 SF 702, from the fund or funds to which are credited the sale of bonds authorized by Ordinance No. 508-2022, passed May 23, 2022, if the City sells such bonds, and other funds as approved by the Director of Finance. (RQS 0103, RL 2022-73)

Section 4. That the Director of Capital Projects is authorized to enter into any agreements necessary to implement the Improvement.

Section 5. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
